Once your application has been accepted, restaurants are required to submit a current copy of their business license, liability insurance and payment (if applicable).

I. The Restaurant/Vendor understands and agrees that there is no entitlement to any certain location in the festival and agrees and grants St. Francis Fall for Greenville or its agent the full discretion regarding location at The St. Francis Fall for Greenville Festival.

II. Upon signing below, the Restaurant/Vendor agrees, understands and acknowledges that St. Francis Fall for Greenville does not and cannot guarantee the turn-out, the volume of sales, the weather conditions or the success of any particular vendor or the festival itself. Furthermore, Restaurant/Vendor specifically agrees that it will hold harmless St. Francis Fall for Greenville for any and all damages or losses that may occur as a result of festival participation by the by the Restaurant/Vendor. Specifically, Restaurant/Vendor understands and appreciates that there are inherent risks involved in festival participation and agrees to accept the risk of loss occasioned by participation in St. Francis Fall for Greenville.

III. Restaurant/Vendor understands and agrees that space in St. Francis Fall for Greenville is limited and submission of an application does not guarantee acceptance into St. Francis Fall for Greenville. Moreover, once St. Francis Fall for Greenville accepts an application and notifies Restaurant/Vendor of acceptance into St. Francis Fall for Greenville festival, all fees become non-refundable after Friday, August 27, 2010.

IV. If any provision of this agreement shall be held void, void able, invalid, or inoperative no other provision of this agreement shall be affected as a result thereof, and accordingly, the remaining provisions of this agreement shall remain in full force and effect as though such void, void able, invalid, or inoperative provision had not been contained herein.

V. In the event of a breach of this agreement by Restaurant/Vendor, St. Francis Fall for Greenville shall be entitled to recover from Restaurant/Vendor its attorneys' fees in connection there with in addition to the costs of any action, suit, or proceeding to enforce the terms of this Agreement.

VI. Except as otherwise provided in this agreement, all rights and remedies herein or otherwise shall be cumulative and none of them shall be in limitation of any other right or remedy.

VII. This agreement shall be governed by the laws of the state of South Carolina.

VIII. This agreement sets forth the entire understanding of the parties hereto relating to the subject matter hereof. No modification, amendment, waiver, termination or discharge of this contract or of any of the terms or provision hereof shall be binding upon any of the parties hereto unless confirmed by a written instrument signed by authorized agents of the Restaurant/Vendor and St. Francis Fall for Greenville. No waiver by either party of any term or provision of this contract or of any default hereunder shall affect the respective rights thereafter to enforce such term or provision or to exercise any right or remedy in the event of any other default, whether similar or not.

IX. It is agreed that all rules and regulations attached to this agreement are a part thereof and that no agreement other than those contained herein shall be binding upon the parties unless in writing and signed by an official of St. Francis Fall for Greenville.
